**RESOLUTION TO AWARD THE UPGRADING OF FEEDER LINES OF THE NEW BUILDING
AT JESUS DELA PEÑA NATIONAL HIGH SCHOOL TO MARAKESH ENTERPRISES**

Whereas, the Schools Division of Marikina City had advertised in its website and in the PhilGEPS website and posted at the bulletin board of the Division Office on **May 7-10, 2021**, the **REQUEST FOR QUOTATION (RFQ)** for the “**Upgrading of Feeder Lines of the New Building at Jesus Dela Peña National High School**” with an Approved Budget for the Contract (ABC) amounting to **Php 616,687.82**;

Whereas, until the Opening of Quotation on May 10, 2021, the BAC through the BAC Secretariat, received one (1) quotation from **Marakesh Enterprises** with an offer amounting to **Php 612,742.13**;

Whereas, the bid proposal of **Marakesh Enterprises** was found to be **COMPLYING** and emerged as the **LONE CALCULATED QUOTATION** after the Bid Evaluation on the same date;

Whereas, the **BAC** conducted Virtual Post-Qualification to **Marakesh Enterprises** on May 12, 2021 and declared it as **RESPONSIVE**;

Wherefore, upon careful examination and validation of the Post Qualification results, the members of the Bids and Awards Committee unanimously approved to recommend to the Officer-in-Charge, Office of the Schools Division Superintendent, **MS. SHERYLL T. GAYOLA** to award the contract for the “**Upgrading of Feeder Lines of the New Building at Jesus Dela Peña National High School**” to **Marakesh Enterprises**;

Resolved as it is, hereby resolved to recommend to the Officer-in-Charge, Office of the Schools Division Superintendent, **MS. SHERYLL T. GAYOLA** to award the contract for the above project to **Marakesh Enterprises** in the amount of *Six Hundred Twelve Thousand Seven Hundred Forty-Two Pesos and Thirteen Centavos (Php 612,742.13)*;
